COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 1st Degree - Sale - 17 Grams or More-Cocaine or Meth w/in 90-Day Period

Minnesota Statute: 152.021.1(1), with reference to: 609.101.3, 152.021.3(c)

Maximum Sentence: 40 YEARS AND/OR \$300,000-\$1,000,000

Offense Level: Felony

Offense Date (on or about): 12/06/2018

Control #(ICR#): 18400780

Charge Description: That on or about 12/6/2018, in Hennepin County, Minnesota, Christina Suzanne Lusk unlawfully sold, gave away, bartered, delivered, exchanged, distributed, disposed of to another, offered to sell, agreed to sell, manufactured or possessed with intent to sell one or more mixtures of a total weight of 17 grams or more containing cocaine or methamphetamine.

Minimum Sentence: 65 MONTHS

COUNT II

Charge: Drugs - 1st Degree - Possess 50 grams or more - cocaine or methamphetamine

Minnesota Statute: 152.021.2(a)(1), with reference to: 609.101.3, 152.021.3(c)

Maximum Sentence: 40 YEARS AND/OR \$300,000-\$1,000,000

Offense Level: Felony

Offense Date (on or about): 12/06/2018

Charge Description: That on or about 12/6/2018, in Hennepin County, Minnesota, Christina Suzanne Lusk unlawfully possessed one or more mixtures of a total weight of 50 grams or more containing cocaine or methamphetamine.

Minimum Sentence: 65 MONTHS

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about December 6th, 2018, officers executed a search warrant at the residence of Defendant CHRISTINA SUZANNE LUSK, 1420 Portland Avenue South #202.

In the residence, officers recovered various methamphetamine quantities throughout the home, a digital scale in the kitchen cabinet and drug notes from the coffee table.

Officers also recovered a mailing in the bedroom in Defendant's name and documents in Defendant's former legal name, Craig Lusk.

Inside the bedroom, officers recovered a total of 697.9 grams of methamphetamine, mailings for Defendant, two digital scales, large quantities of baggies and \$5,166.00.

Defendant was subsequently arrested on a DOC warrant. Defendant admitted to living at 1420 Portland Avenue South #202.
